The Rensselaer County Farmers' Market location is Twin Town Little League Park, 95 Williams Road, North Greenbush, NY.

- Each market booth is 12 ft. wide and will be assessed at a rental fee of **\$250.00 per season or \$65.00 per 4 consecutive weeks**. The fee is payable to the **Rensselaer County Farmers' Market Committee**. Vendors are offered a reduction in annual membership/seasonal fees for attending a pre-season meeting. The reduced fee will be \$200.00 for the full season and \$60.00 for 4 consecutive weeks.

Payment for booth space is due the first day of the market season. Non-payment may result in forfeiture of market privileges.

The market season runs from **June 3, 2010 to October 14, 2010**. The market will operate every Thursday from 2:30 p.m. to 5:30 p.m. If the products you offer for sale does not allow you to participate for the entire season, please indicate which dates you plan on selling at the market:

You must provide proof of product and general liability coverage in the amount of \$1 million dollars each and Rensselaer County, 1600 7th Ave., Troy, NY 12180, and the Town of North Greenbush, 2 Douglas Street, Wynantskill, NY 12198, must be named as an additional insured. A certificate of insurance must remain on file with the Secretary.

Provide copies of all licenses and/or permits necessary to the types of products you are planning to sell; i.e. Health Dept. permits, nursery license, etc.

I, the undersigned, have read the Rules and Regulations of the Rensselaer County Farmers' Market and do agree to abide by all of the rules and regulations.
